- (e) No shareholder of the Company was required under the Listing Rules to abstain from voting on the resolutions at the AGM.
- (f) None of the shareholders of the Company have stated their intention in the Company’s circular dated 29 April 2024 to vote against or to abstain from voting on any of the resolutions at the AGM.

- (g) The Company's Hong Kong branch share registrar, Tricor Investor Services Limited, acted as the scrutineer for the vote-taking at the AGM.
- (h) All directors of the Company (except for Ms. Zhang Shu and Mr. Feng Ke, who were unable to attend due to other work commitment) attended the AGM.
